## Presentations: *Breaking Barriers and Lineage Societies*

### Janice Bryant – Society of First African Families of English America (SOFIA)

- Explained lineage society membership requirements: proof of ancestry before March 5, 1770 in English colonies.
- Outlined application process: birth, marriage, death records, land patents, emancipation papers.
- Highlighted benefits: heritage recognition, genealogical support, networking, leadership opportunities, scholarships, and youth engagement.

- Shared emancipation papers of her ancestor **Fannie Hickman (born 1765, Georgia)**, freed by Georgia legislature in 1834.
- Demonstrated research methods using land plats, FAN club analysis, and Georgia Black Codes to trace family connections and understand restrictions on free persons of color.

### **Jonnie Ramsey Brown – Sons and Daughters of the U.S. Middle Passage**

- Presented the importance of formally proving lineage to enslaved ancestors.
- Emphasized honoring enslaved ancestors' contributions to building America and preserving their legacy.
- Reviewed reparations initiatives in California, New York, Evanston (IL), Asheville (NC), Georgetown University GU272 descendants, and Howard University's slavery fund.
- Explained application requirements and acceptance of "negative proof" when direct documentation of enslavement is unavailable.
- Compared lineage applications to tax returns: a way to summarize and present proof efficiently.
- Encouraged members to prepare lineage applications to strengthen research and readiness for future opportunities.

### **Devra Harney – Breaking Barriers in Lineage Societies**

- Shared her genealogical journey, documenting lineage back to the 15th century.
- Specializes in African American slave research, U.S. railroads, and Black church communities.
- Contributions include research for PBS *Finding Your Roots* and leadership roles in genealogical societies.
- Highlighted tracing her surname "Harney" back to Ireland (variant "Arnie").
- Discussed challenges and breakthroughs in proving African American lineage for societies traditionally dominated by white narratives.
- Advocated for youth engagement in genealogy, including her 2025 genealogy camp initiative.
